Commissioner McGill / Clark to disagree with the Street Tree Advisory Committee recommendation and approve removal of the Canary Island Palm at 1435 Gillespie Street on the condition that the applicant plant a canopy tree, either the designated street tree or another tree in consultation with the urban forestry staff. On the basis that a reasonable and practical development of the property requires removal of the tree.
