A RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA BARBARA AMENDING RESOLUTION NO. 23-076, ADOPTING THE BUDGET FOR FISCAL YEAR 2024, TO APPROPRIATE \$3,100, AND APPROVE AN INCREASE OF REVENUE AND EXPENDITURE APPROPRIATIONS IN FISCAL YEAR 2024 IN THE PARKS AND RECREATION DEPARTMENT, GOLF DIVISION, IN THE AMOUNT OF \$3,100

WHEREAS, in accordance with the City Charter, the City Administrator filed with the Council a proposed budget for the fiscal year beginning July 1, 2023;

WHEREAS, the City Council is required to adopt a budget before the beginning of the fiscal year on July 1, 2023;

WHEREAS, the City Charter provides that at any public meeting after the adoption of the budget, the City Council may amend or supplement the budget by motion adopted by the affirmative votes of at least a majority of the total members of the City Council; and

WHEREAS, as authorized by Resolution No. 23-076, this Resolution approves the amendment to the budget as provided herein.

NOW, THEREFORE, be it resolved by the Council of the City of Santa Barbara that in accordance with the provisions of Section 1205 of the City Charter, the budget for the fiscal year 2024, as adopted by Resolution No. 23-076, is hereby amended as follows:

- 1. The Council approves appropriation in the amount of \$3,100 to the Parks and Recreation Department, Golf Division.
- 2. The Council approves of the increase in revenue and expenditure appropriation of \$3,100 in the Fiscal Year 2024 Parks and Recreation, Golf Division.
