<p>Access Advisory Committee 4 Majority of members shall be residents of the City of Santa Barbara; other members may be full-time employees working within the City of Santa Barbara, or residents of the South Coast are of the County of Santa Barbara. Members shall demonstrate an interest in, and commitment to, furthering accessibility within the limits of the City of Santa Barbara, and be from the following communities: disability community; or architectural, engineering, or building community.</p>	4
<p>Architectural Board of Review 2 Members need not be qualified electors* of the City at the time of their appointment so long as they are qualified electors* of the County and remain so during their term. Members shall possess professional experience in related fields, including but not limited to, landscape architecture, building design, structural engineering or industrial design, or be a licensed architect.</p>	2
<p>Arts Advisory Committee 1 May be qualified elector* of the City, or South Coast Area resident.</p>	1
<p>Building and Fire Code Board of Appeals 3 Member shall be a resident of the City or adjoining unincorporated area of Santa Barbara County, and shall demonstrate knowledge and expertise in specialty areas governed by the construction and fire codes of the City. Per Santa Barbara Municipal Code Sections 22.04.020 (H) (113.1.2) & 8.04.020 (E) (114.1.2), at least one vacancy must be filled by a member who is physically handicapped in order to meet the mandatory requirement that the composite of the board have at least 3 members that are physically handicapped in order to hear items that involve Chapter 11 of the California Building Code and Chapters 11A and 11B of the California Fire Code.</p>	3
<p>Citizen’s Oversight Commission 1 May not hold any full-time paid office or employment in City government. One appointee must be a member of the Hospitality Community.</p>	1
<p>Civil Service Commission 3 Members must be qualified electors* of the City.</p>	3
<p>Community Development and Human Services Committee 7 Members must be qualified electors* of the County of Santa Barbara, or employees of the designated organizations. One representative from each of the following specified categories or organizations: Oak Park Neighborhood; Westside/Lower Westside Neighborhood; Latino community; Human services organization; Homeless-related Services Organization; or Disabled community.</p>	7
<p>Community Events and Festivals Committee 4 Appointees may not hold any full-time paid office or employment in City government. For this vacancy, we need one representative of the cultural arts.</p>	4

* Resident of the City of Santa Barbara who is a U.S. citizen age 18 or older.

Creeks Advisory Committee..... 4
 May be either City or Non-City residents, and should represent one of the following categories: Representative of the hotel/lodging industry; Representative with experience in environmental/land use issues (e.g., land use planning, environmental/natural resource protection/preservation, habitat restoration, water specialist, biologist, or hydrologist, etc.); Representative with experience in ocean use (e.g., recreational user or commercial fisherman, etc.), business, environmental issues, or public at-large.

Downtown Parking Commission 2
 One appointee must be a resident of the City. The other appointee may be a City or County resident.

Harbor Commission 2
 Member may be a qualified elector* of the City or County.

Historic Landmarks Commission..... 1
 Members must be qualified electors* of the City.

Housing Authority Commission 1
 Member may be a non-City resident representing the public at large.

Library Board 1
 Member must be qualified elector* of the City.

Living Wage Advisory Committee 2
 Members must represent specific categories. One member who is employed by a local Santa Barbara area non-profit entity; one member who is either an owner or a manager of a service contractor subject to the City’s Living Wage Ordinance; one member who is a representative of the public at-large.

Neighborhood Advisory Council..... 8
 Members must be residents of the City of Santa Barbara but need not be qualified electors*, who must be a representative of one of the following neighborhoods: Eastside Neighborhood; Lower Eastside Neighborhood; Westside Neighborhood; Lower Westside Neighborhood; West Downtown Neighborhood; Laguna Neighborhood; or the Public at Large.

Parks and Recreation Commission 1
 Appointees must be qualified electors* of the City. One member may be an individual of age 16 years of older.

Planning Commission 2
 Appointees must be qualified electors* of the City.

Rental Housing Mediation Board 9
 Members may be City or non-City residents, and must meet the definitions of one of the following specific categories; four Tenant Mediator member must rent or lease a dwelling with no ownership of residential properties; one Homeowner Mediator who owns and

resides in a single-family residence with no ownership of other residential properties; Four Landlord Mediators (a Landlord Mediator must own or manage residential properties for consideration or compensation, whether single or multiple units). Non-City residents must reside in a jurisdiction which contracts with the Rental Housing Mediation Program for services.

Santa Barbara Youth Council.....	4
Members must be between the ages of 13 – 19 years old. Majority of members must be residents of the City. Other members may be residents of the County. Members must be students from the following categories: Two members from a local alternative, community, or continuation high school; one student from a local private high school or independent studies; one representative of the public at large.	
Sister Cities Board.....	1
Appointee may be qualified elector* of the City or County.	
Water Commission	3
Appointee must be qualified elector* of the City.
