PARKING LOT REPAVING/RESTRIPING SUBMITTAL REQUIREMENTS

The City of Santa Barbara requires a building permit to restripe or, repave and restripe an existing parking lot. The following items shall be submitted for a building permit application for repaving or re-striping of existing parking lots. **Restriping permits cannot be approved over-the-counter.***

PLANS –Plans must be minimum 18" x 24" in size and must be complete, accurate and DRAWN TO SCALE (e.g., 1/8" = 1'). Plans must be legible and be submitted in PDF format.

Show the following information on your plans:

- 1. <u>Project Data</u>: Include the project address, scale, zone, APN, property owner & architect/designer information (name, address, phone number); and scope of work.
- 2. <u>Architect/Designer Signature</u> on all submitted plan sheets prepared by the architect/designer.
- 3. Parking Data Information: 1) Provide a calculation on the plans that shows the existing number of parking spaces, the required (per Zoning Ordinance) number of parking spaces, and the proposed number of parking spaces on site; 2) Indicate the required number of accessible parking spaces; 3) Show calculation for required parking, per SBMC §28.90.100 (e.g., 8,000 s.f. office building; required parking is 1/250 s.f. = 32 required parking spaces); 4) Include existing, required, and proposed number of bicycle parking spaces.
- 4. <u>Site Plan</u>: 1) Provide a scaled site plan showing property lines, zoning setbacks, streets, driveways, outline and label the footprint of all structures on site; 2) Show true north arrow; 3) Show all paved areas, landscaped areas and planters; 4) Identify existing and proposed paving materials (permeable or non-permeable); 5) Identify any proposed improvements/repairs in the City right of way, including parkway landscaping.
- 5. Parking Areas: 1) Show all existing and proposed parking spaces; 2) Show stall dimensions and angle of parking spaces; 3) Show bay-width dimension; 4) Show width of driveway; 5) Show accessible path of travel to accessible building entrances and public sidewalk; 6) Number the parking spaces (1,2,3,..); 7) Identify compact stalls; 8) Show loading and unloading area for commercial vehicles if applicable. 9) Show location of trash storage.
- 6. <u>Design Review:</u> If minor changes from approved plans are proposed, please submit current color photographs of the site; include photos of adjacent properties, surrounding neighborhood area and streetscape, to provide an accurate depiction of the location of the subject parcel(s). Photographs <u>must</u> be clear, visually legible, in color **AND** a <u>minimum</u> of 3" x 5" size. Dark and/or discolored photographs are not acceptable.

*Note: We highly recommend that prior to submitting an application to repave a parking lot, the applicant review the last permitted archive parking plans for the property. The proposed re-stripe plan must match the last permitted plan, or additional requirements will apply. If alterations are proposed, the project may require design review approval or a redesign to meet current requirements. Please contact City Records and Archives (805) 564-5485 to make an appointment to review the archive plans.
