ASSIGNED BERTHS: Fees assessed monthly per foot of boat or slip length, whichever is longer

Table listing berth fees for various slip lengths (20 to 90 feet) and other services like Fisherman's Floats and side ties.

TRANSFER FEES: Slip Permit reassignment (transfer), cost per 2 partners added to Slip Permit

Table listing transfer fees for different slip lengths (20 to 60 feet) and Commercial Fishing Slips.

Wait List Slip Permit Transfer Fee: 5-year sliding scale. Request details.

VISITOR BERTHS:

- Payment is due in advance. No Refunds
• Rate is per foot, length overall with a maximum stay of 28 nights
• Commercial fishing vessels remain at base rate with two current CA Dept. Fish & Wildlife tickets bi-weekly

WHARFAGE AND DOCKAGE:

Table detailing wharfage and dockage fees for various services like hoists, commercial ice, and water.

PENALTIES:

Table listing penalties for late fees, impound fees, and unauthorized vessel storage.

GATE KEYS: non-refundable

Table listing gate key fees for Key Cards, Key Fobs, and keys in excess of 5.

PERMITS:

Table listing various permits and their fees: Liveaboard (\$143.00/monthly), Catamaran Beach Storage (\$350.00/season), East Beach Mooring Permit (\$400.00/yearly), West Beach Storage (\$375.00/yearly), West Beach Rack Storage (\$2,000.00/yearly), Skiff Row (\$300.00/yearly), Bicycle Locker (\$125.00/yearly), Business Activity Permit (Service \$25.00/yearly, Charter \$250.00/yearly, Late renewal fee \$25.00).

ADMINISTRATIVE FEES:

Table listing administrative fees: Processing Fee (\$100.00), Duplicating Fee (\$0.20/page), NSF Check Fee (\$25.00), Waiting Lists (Bike Locker \$40.00/yearly, Lottery \$50.00, Slip Permit \$40.00/yearly, Liveaboard \$40.00/yearly).

Non-emergency – a fee shall be charged for Harbor Patrol services except for bona fide emergencies, at a rate based on current Waterfront contract hourly service rates for labor and equipment.

MEETING ROOM FEES: Fees for the use of the Marine Center Classroom, Waterfront Community Meeting Room, or Waterfront Conference Room shall be:

- \$50 per hour/ \$200 per day max for commercial and/or private non-ocean related users.
\$25 per hour/ \$100 per day max for commercial and/or private ocean related users.
\$25 per hour/ \$100 per day max for non-profit and educational institutions where food and/or drinks are consumed.
\$15 per hour/ \$50 per day max for non-profit and educational institutions where food and/or drinks are not consumed.

A refundable security deposit of \$100 is required from all room users. Cleaning costs in excess will be charged to the user.

PARKING: Maximum vehicle length 22' in Harbor Lot.

Annual Parking Permits:

Table listing annual parking permit details: General Permit (\$145.00, Not prorated), Slip Permittee Permit (\$145.00, Restricted to Slip Permittee only), Oversized Vehicle Permit (\$50.00 extra, Approval required), Vehicle (\$3.00/hour, \$18.00 maximum/day), Stearns Wharf (\$3.50/hour, First 90 minutes free), Oversized Vehicles (\$6.00/hour, \$36.00 max/day), Boat Trailer (\$3.00/hour, \$6.00 max/day), Launch Ramp Washdown (\$1.00/5 minutes).
