Hoist 4 -----	\$0.75/10 mins----	Quarter operated
Commercial Ice -----	\$0.20/lb -----	200 lb minimum
Water -----	\$15.50/1,000 gal	Includes wharfage, \$15.50 minimum

PENALTIES:

Slip Permit monthly fee late fee -----	\$50.00
Visiting vessel late fee -----	\$15.00
Impound fee -----	\$250.00
NSF “Bounced” Check Fee -----	\$25.00
Penalty for leaving harbor owing visitor fees-----	Double amount owed
Penalty for visitors over 28 nights -----	\$100.00 - \$250.00 per night depending on vessel size
Unauthorized vessel storage on beach -----	\$50.00/day plus impound fee
Unauthorized vessel storage in marina -----	Daily visitor fee plus impound fee

Moving or Commercial -----	Up to \$1,000.00 per day
Still Photography -----	Up to \$500.00 per day, dependent on crew size
TV & Movie Feature Filming -----	Up to \$1,000.00 per day, dependent on crew size
Marine Center Classroom -----	\$75.00 per hour/\$500 Max - \$100.00 Deposit
Waterfront Community Meeting Room -----	\$60.00 per hour/\$300 max - \$100.00 Deposit

PARKING:

General Permit -----	\$145.00 -----	Max of 72 hours
Slip Permittee Permit -----	\$145.00 -----	Limit of one per Slip
Oversized Vehicle Permit -----	\$50.00 extra -----	Approval required
Vehicle -----	\$3.50/hour -----	\$20.00 max/day
Stearns Wharf -----	\$4.00/hour -----	\$40.00 max/day, first 90 min free, no validation required
Oversized Vehicles, 33' max length -----	\$7.00/hour -----	\$40.00 max/day, restricted to oversized stalls
Boat Trailer -----	\$3.50/hour -----	\$8.00 max/day, restricted to launch ramp trailer stalls
Launch Ramp Washdown -----	\$1.00/5 min
