### AUTHORIZATION FOR WEBSITE POSTING

- I understand that posting is not an endorsement of the preapproved ADU plan and is not an approval of a future ADU application.
- I agree that the City will not be held responsible for any copyright infringement that occurs via the public accessing the plans on the City's website.

- I understand that I may submit a written request to the City to have the posting removed from the City website, and that the City shall remove the posting within 30 days of receipt of my request. (Email to [ADU@SantaBarbaraCA.gov](mailto:ADU@SantaBarbaraCA.gov).)
- I understand once an ADU plan is preapproved by the City, the preapproval will remain valid until the City adopts new building or zoning codes that apply to a preapproved ADU plan. The City will provide notice when such changes take place and how updated plans can be submitted. Additional plan check fees may apply to each resubmittal.
- I understand that owner-requested modifications to the preapproved plans are not allowed under the City's Preapproved ADU Program and may result in the loss of preapproved status, additional permit review, inspection, and fees required due to changes in the building design or submittal documents.
- I will, to the fullest extent permitted by law, indemnify and hold the City of Santa Barbara its officials, officers, employees, volunteers, agents, harmless from any and all claims, suits, liability, demands, judgments, or costs arising out of or resulting therefrom on account of any injury, death, damage or loss to persons or property. Indemnification includes and direct claims from the Applicant
