Interviews:

1. All applicants that are approved must interview with City Council during a regular City Council meeting to remain eligible for appointments. Interviews have been scheduled to take place at the November 10th regular meeting. Applicants will be notified via email and asked to make an appointment for their interview with City Council.
2. All Santa Barbara Youth Council (SBYC) applicants that are approved must be interviewed by the current members of the SBYC in addition to City Council, to remain eligible for appointments. Applicants will be notified via email on the dates the current SBYC will be holding interviews, as well as being asked to make an appointment for their interview with City Council.

Members also cannot be any current or former law enforcement officer or firefighter, or where relevant or comparable any member of the public, who has a sustained finding of serious misconduct made by any law enforcement agency, independent investigator contracted by a public agency, or court.
