PUBLIC COMMENT: Public comment on matters not listed on the agenda will occur at the beginning of the meeting. Members of the public wishing to speak must "raise their hand" in the Zoom platform by selecting the virtual hand icon during the presentation of that item. When persons are called on to speak, their microphone will be activated by City staff and the speaker will be notified that they can now unmute themselves in order to begin speaking. The speaker will then need to unmute themselves by selecting the 'mute/unmute' icon or pressing Ctrl+Alt+A on their keyboard.

When persons are called on to speak, their microphone will be activated the speaker will be notified by Commission staff that they can now unmute themselves in order to begin speaking. The speaker will then need to unmute themselves by selecting the 'mute/unmute' icon or pressing Ctrl+Alt+A on their keyboard.

Each speaker will be given a total of 3 minutes to address the Commission. Pooling of time is not allowed during general public comment. The time allotted for general public comment at the beginning of the 6:00 p.m. session is 30 minutes. The Airport Commission, upon majority vote, may decline to hear a speaker on the grounds that the subject matter is beyond the Commission's subject matter jurisdiction.

PUBLIC COMMENT ON AGENDIZED ITEMS: Members of the public wishing to speak on a matter on the agenda must "raise their hand" in the Zoom platform by selecting the virtual hand icon during the presentation of that item. The "raise hand" icon is generally located on most devices in the upper right hand corner of the screen. For those who need accessibility accommodation in using the "raise hand" function, please contact the Commission's office by 5:00 p.m. the day before the meeting for assistance. 8. Subject: Lease Agreement – Ace Rivington, Inc.

Recommendation: That Airport Commission approve and authorize the Airport Director to execute a five (5) year lease agreement with Ace Rivington, Inc., a California Corporation, for approximately 1,390 square feet at 90 Dean Arnold Place, Unit A at Santa Barbara Airport for a denim apparel business, with a lease commencement date to be determined upon completion of needed maintenance/repairs to the space. The total annual rent for the first year of the agreement is \$22,776.60.

9. Subject: Lease Agreement – Derrick's Roofing, Inc.

Recommendation: That Airport Commission approve and authorize the Airport Director to execute a five (5) year lease agreement with Derrick's Roofing, Inc., a California Corporation, for 3,280 square feet of Building 223 and 3,700 square feet of adjacent yard space at 94 Frederick Lopez Road, Suite C, at Santa Barbara Airport, with lease commencement on March 1, 2022 and rent commencement on April 1, 2022. Total annual rent for the first agreement year will be \$55,185.24, not including utility costs, insurance or County possessory interest taxes.
