1. UCSB Social Print Lab: Stearns Wharf [ACTION REQUIRED]

In March 2022, UC-Santa Barbara Biology and Art students propose to organize and exhibit a series of flags on Stearns Wharf as part of a course collaborating with the Museum of Contemporary Art Santa Barbara (MCASB), The Santa Barbara Museum of Art (SBMA) and the Alliance of Santa Barbara Museums as part of the Impact, Climate Change and the Urgency of Now initiative.

2. Independent Living Resource Center Education Campaign [NO ACTION REQUIRED]
