1. UCSB Social Print Lab: Stearns Wharf

2. Independent Living Resource Center Education Campaign

Jacob Lesner-Buxton, Systems Change Coordinator with the Independent Living Resource Center, shared information about a new campaign to partner with musicians to encourage venues to pursue educational resources supporting increased accessibility and inclusion of audiences. He also shared an invitation to "Ask an Able-bodied Person," a safe, fun, experimental space where people with disabilities can discover more about able-bodied culture. People are invited to join and explore questions like:

"When did you know you didn't have a disability?"

"Why don't certain people without disabilities ask people with speech disabilities to repeat

themselves?"

"Do you feel a connection to others without disabilities?" "How does it feel to walk/drive a car/be understood by strangers?"
