#### 6. MEASURE C ANNUAL ACCOUNTABILITY REPORT FISCAL YEAR 2023

The committee heard an overview of the Measure C Annual Accountability Report for Fiscal Year 2023. Staff presented updates on projects funded by Measure C for Police, Streets, Facilities, Library, Parks and Recreation, and Public Works.

#### 7. PROVIDE DIRECTION ON NEXT FIVE YEARS OF MEASURE C FUNDING

The committee recommends the following priorities in order of importance for Measure C Funding over the next five years:

- 1. Construction and Debt Service for a new police station facility.
- 2. Repair local streets throughout the City, including related street infrastructure, improving toward a goal of PCI 75+ in the next 10-12 years.
- 3. Address drainage infrastructure, completing a full assessment of the City's drainage infrastructure.
- 4. Community projects to support the City's parks and libraries.
- 5. Business district infrastructure projects, with a focus on the State Street Promenade.
- 6. Maintenance of City Buildings.
- 7. Address homelessness, prioritizing housing and facilities.

It was also determined that Chair Gorin will attend and speak on behalf of the committee at City Council when the report is presented to the Council. (Silver/Sarafian, 5:0 – Absent: Epstein)

### 8. STAFF UPDATE REGARDING PROCUREMENT BALLOT MEASURE
