1. FINAL CDHSC FUNDING RECOMMENDATIONS

The subcommittee discussed and formulated final recommendations for funding based on the committee's average applicant scores and prior year funding amounts.

- Motion: Approve all CDBG Capital Project funding recommendations.
- Action: Campbell/Montenegro, 5/1/1. (Kouakoua abstained, Gonzales absent.) Motion carried.
- **Motion:** Approve funding recommendations for DVS, Equal Learning Fund, FSA, Foodbank, Friendship Center, Good Sam, Hillside
- Action: Kouakoua/Rolle, 4/2/1. (Loza and Campbell abstained. Gonzales absent.) Motion carried.
- **Motion:** Approve funding recommendations for Legal Aid, Planned Parenthood, Standing Together to End Sexual Assault.
- Action: Rolle/Campbell, 4/2/1. (Loza and Gullap-Moore abstained. Gonzales absent.) Motion carried.
- **Motion:** Approve funding recommendations for Santa Barbara Neighborhood Clinics, and Transition House.
- Action: Gullap-Moore/Montenegro, 4/2/1. (Loza and Kouakoua abstained. Gonzales absent.) Motion carried.
- Motion: Approve all other funding recommendations.
- Action: Gullap-Moore/Campbell, 5/1/1. (Loza abstained. Gonzales absent.) Motion carried.

The committee discussed a contingency plan in the event CDBG funds were higher or lower than expected and made the following recommendations:

1. In the event CDBG funds are increased for Public/Human Services – The excess available funds will be distributed to the five highest scoring applicants that did not already receive full funding until the excess is depleted.

2. In the event CDBG Funds are decreased for public/Human Services – The deficit funds will be divided equally among the ten lowest-scoring Priority 2 applicants, and reduced or eliminated, until the deficit is depleted. If as a result of this contingency plan, the recommendation to a particular applicant is less than the City's \$9,000 minimum grant amount, that minimum will be waived.

3. For Capital grants, In the event CDBG funds are increased - The excess available funds will be equally distributed among all the applicants that did not already receive full funding, excluding the applicants that did not receive any funding. If the increase is more than \$25,000 the committee will reconvene to make a revised recommendation.

4. In the event CDBG Funds are decreased – The recommended funds will be reduced equally among all applicants until the deficit is eliminated. If the deficit is more than \$25,000 the committee will reconvene to make a revised recommendation.

Motion: Approve Contingency plan.

Action: Campbell/Kouakoua, 5/1/1. (Gullap-Moore abstained. Gonzales absent.) Motion carried.
