#### What is the Community Formation Commission?

- The Community Formation Commission (CFC) is a 12-member commission that is tasked with the specific duty to develop a recommendation to the City Council for civilian oversight of the Santa Barbara Police Department
- This commission is NOT providing oversight of SBPD
- What does that mean?
  - Exploring different civilian police review systems,
  - Researching existing and new police accountability systems,
  - And reviewing SBPD department's existing standards and protocols

#### **CFC Members**



- We are a diverse group with different perspectives on various issues.
- Through facilitated discussions our aim is to work together to reach recommendations that represent the *whole* community.
- We understand that individuals and groups have different experiences, perspectives, relationships, and needs with law enforcement and our intention is to consider them all.

#### The CFC Partnerships

- The 12-member commission is working with the following organizations:
  - National Association for Civilian Oversight of Law Enforcement (NACOLE)
    - This national organization that works to provide education and support to jurisdictions implementing oversight.
    - NACOLE is facilitating our discussions and assisting us in developing our recommendation.
  - Center for Court Innovation (CCI)
    - CCI works to create a fair, effective, and humane justice system.
    - CCI will help the Commission develop a survey and analyze data from our outreach effort.

# Types of Oversight Models

#### **Review Focused**

An individual or a board/commission authorized to review completed internal investigations - can agree/disagree with findings.

Provides community members the opportunity to provide feedback on the complaint investigation process.
Community review of investigations may increase public trust

in the process.

#### Auditor/Monitor Focused

- Often have more robust reporting practices than other models.
- May be more effective at promoting long-term systemic change in police departments.
- Allow the agency to actively engages in many or all of the steps of the complaint.
- Generally, less expensive than full investigative agencies.

# Types of Oversight Models (Cont'd)

#### Investigation Focused

- Full-time civilian investigators may have highly specialized training.
- Investigations conducted by oversight agency does not rely on investigators from within the police department.
- Civilian-led investigations may increase community trust in the investigation process.

#### Hybrid

- Contain elements from one of more of the three models.
- Have been developed to address that needs of a specific community and conform to state or local laws.
- Are increasingly common.

#### Where we are Currently in the CFC Process

- The Community Formation Commission has preliminarily recommended a hybrid agency that would incorporate aspects of the review-focused and auditor/monitor-focused models of civilian oversight.
  - In addition, the CFC recommends that the agency have the ability to conduct independent investigations, when necessary.
