Summary of Progress:

The CFC Data and Analytics workgroup has used our meetings to relationship-build and set a foundation for our future data analysis. The group discussed the types of data and analytics we think the Commission would need to develop a recommendation.

The discussion included current and future data collection practices in Santa Barbara. Lieutenant Shawn Hill provided the workgroup insights about the current national trends in data collection and analysis in policing. Notable trends for the Commission to consider are partnering with academia to analyze data, hiring professional crime data analysts, or contracting with external auditors. In addition to focusing on the data collected in the City of Santa Barbara, the workgroup discussed working with NACOLE to analyze national data trends and develop a list of data relevant to the future oversight body.

The Data and Analytics workgroup discussed placing particular emphasis on balancing quantitative and qualitative data, and providing the proper context for the data we analyze, so that we can present as comprehensive a picture as possible of data sets. We recognize that data bias will be impossible to eliminate completely, but we can mitigate bias through thoughtful and intentional use of data.

Following feedback from the full Commission on June 9, 2021, the Data and Analytics workgroup will work with NACOLE and Lieutenant Shawn Hill to gather and analyze relevant data to bring back for future review.

Feedback Requested:

The Data and Analytics workgroup would like feedback from the full Commission about the types of data and analytics they would like to see from the workgroup. A working list of desired data can be found below. Please let us know if there are additional topics or statistics that you think would be helpful for the Commission to see in preparation for developing a recommendation to the City Council.
