- Use of force incidents are measured as less than 1% of all total contacts.

FIRE DEPARTMENT UPDATE

Chief Mailes

- Engineer and Captain exams will occur this spring. Academy funding has been approved for future hires.
- A grant for fuels mitigation has been applied for, and updates will be provided for use of funds should the money be granted.
- 70.1% of call are processed in 60 seconds or less, 46.3% turnout time occurs in 60 seconds or less, 72.3% travel time is in 4 minutes or less resulting in a total response time of 6 minutes and 15 seconds in 63.2% of calls.
- Vegetation management will include multiple abatement projects in the city.
