SUBJECT: Live Entertainment Dance Permit Application: "Soul Bites" 423 State St.

DISCUSSION:

On August 8, 2022, an application for a live entertainment dance permit was submitted to the Santa Barbara Police Department for the business at 423 State Street, dba Soul Bites, by the owner of the business, Stirling Nix-Bradley & Rose Nix-Bradley.

The applicant received all necessary approvals from Community Development for the dance permit and completed the required walkthrough site inspection. Per an affidavit signed by Stirling Nix-Bradley, posted and mailed notices of the February 2023 Fire and Police Commission meeting were completed in accordance with the requirements and deadlines set forth in the Santa Barbara Municipal Code. Owner / Manager / Security Manager Stirling Nix-Bradley & Rose Nix-Bradley underwent required Live Scan fingerprinting. The results meet Municipal Code standards. It should be noted that there was a delay in the application process pending the livescan results that were received in December 2022.

According to the application, they will be hosting live entertainment 3 times per week on any Tuesday – Sunday from 12:00 PM – 12:00 AM. The owner plans to use the location as a multi-use space. It will be hosting various events in the morning like yoga classes and a coffee/juice bar workspace during the day. In the evening hours after 12:00 PM it will be a restaurant/ live entertainment venue friendly to all ages. The owner plans to have a minimum of 3 security guards on duty when dancing is happening from the start of the evening through close.

On December 26, 2022, Santa Barbara Police Department staff conducted a site visit. The walkthrough was led by owner Stirling Nix-Bradley. The following information was learned during this visit:

- The upstairs floor of the building will be used as a VIP section. It is an open room overlooking the first floor.
- If dancing were to take place it will be on the first floor in front of the stage area;
- The back door exit leads to a small storage area where bands and other live entertainment performers are expected to leave equipment. This area will not be accessed by the public;
- There are no exterior speakers;
- Security cameras are shown on the security plan, Sterling Nix-Bradley advised the cameras would be moved to have a better view of the common areas. Per Sterling, there is 1 camera in the VIP area, 1 facing the back door, 1 outside in the back storage and 1 facing the bar and front door.
- There is one door at the front of the business which will remain open for patron entry and exit. The back door will only be used by staff and live entertainment performers. The back door will remain closed but unlocked as needed by staff.

Over the past 11 months that Soul Bites has been open, from February 1, 2022 through January 12, 2023, there were 2 calls for service at this location. One was a found property report made by the owner, Stirling who later called back to advise the belongings were no longer being held.

The second was a check the welfare on a transient who was on the sidewalk directly in front of the business. Police officers were able to handle the call for service over the phone. This incident was not related to the business.

The applicant currently holds a Type-41 ABC license (on-premise sale of beer and wine – eating place).

RECOMMENDATION:

The Santa Barbara Police Department recommends that the live entertainment dance permit be issued to Stirling Nix-Bradley & Rose Nix-Bradley, owner of Soul Bites at 423 State Street, with the following conditions:

1. Music and/or entertainment shall not be audible beyond 50 feet from the premise in any direction.
2. Windows must remain closed during hours of dancing.
3. Rear door(s) must be kept closed but unlocked, at all times during the operation of the premises and may not be used for public entry or exit except in the case of emergency and to permit deliveries.
4. Except in the case of emergency, no patrons shall enter or exit the premise through the rear doors.
5. No live entertainment, dancing, or amplifying system or device shall be permitted on any patio or outdoor area. Televisions are permitted on patios and outdoor areas.
6. Licensee shall police the area under their control once an hour to prevent the loitering of persons about the premises.
7. Licensee is responsible for maintaining an orderly line of patrons awaiting entry into the premises. The queue of perspective patrons must not block passage of pedestrians on the public walkway, nor may it extend into any nearby street.

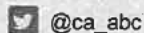

As a seller, you have the right to issue resale certificates for merchandise that you intend to resell. You also have the responsibility of not misusing resale certificates. While the sales tax is imposed upon the retailer,

- You have the right to seek reimbursement of the tax from your customer
- You are responsible for filing and paying your sales and use tax returns timely
- You have the right to be treated in a fair and equitable manner by the employees of the California Department of Tax and Fee Administration (CDTFA)
- You are responsible for following the regulations set forth by the CDTFA

As a seller, you are expected to maintain the normal books and records of a prudent businessperson. You are required to maintain these books and records for no less than four years, and make them available for inspection by a CDTFA representative when requested. You are also required to know and charge the correct sales or use tax rate, including any local and district taxes. The tax rate applicable to your sales or use may not necessarily correspond to the tax rate of your business address displayed on this permit. You are also expected to notify us if you are buying, selling, adding a location, or discontinuing your business, adding or dropping a partner, officer, or member, or when you are moving any or all of your business locations. If it becomes necessary to surrender this permit, you should only do so by mailing it to a CDTFA office, or giving it to a CDTFA representative.
