

Banales Stipulated Judgment

Pursuant to the Banales Stipulated Judgment:

"the intent of the Parties is the electoral district map shall include two electoral districts in which Latino eligible voters constitute a majority of the eligible voters according to the most recently available relevant estimates from the Census Bureau's American Community Survey, tailored to the greatest extent possible in a manner consistent with the federal and state law, so as to address any issue of vote dilution."



Community Input


- Creation of two Latino/a majority minority districts
- Every district should include a portion of State Street
- As many districts as possible should include a portion of the coastal zone
- Each existing district includes commercial areas
- Make minimal changes to preserve existing communities and boundaries



Redistricting Rules and Goals



Santa Barbara Neighborhoods




Santa Barbara Communities of Interest

Many potential examples that can be found on the <u>Story Map</u>:

- Central business district: Area bounded by Sola, Garden, 101 & De La Vina
- □ Historic districts: Biggest includes the C.B.D. and area along the waterfront
- □ School attendance areas: 13 elementary, 3 junior high & 2 high school areas
- □ Fire hazard zones: High fire risk area covering the foothill and riviera areas
- ZIP code areas: 93101 (Downtown + Westside), 93103 (Eastside + Riviera), 93105 (Uptown), 93109 (Mesa), 93110 (Hope)
- □ Land use/zoning areas: Marked differences between certain neighborhoods
- □ Concentrations of socioeconomic interests:
 - **G** Speak Spanish at home: the Eastside and Westside
 - **G** Families with children at home: the Eastside and Westside
 - □ Income \$75,000 or higher: the mesa, the foothills, and San Roque
 - **D** Education BA or higher: the mesa, the foothills, and San Roque
 - Multi-family housing: Downtown and the waterfront
 - Renter housing: Downtown, Eastside, Westside, and the waterfront

Map of Current Plan




Analysis of Current Plan

- □ Equal population
 - Districts 1 and 3 are underpopulated; Districts 4 and 5 are overpopulated
 - District 3 at -11%, District 4 at +9%, so the total deviation is 20%; should be less than 10%
- Voting Rights Act
 - District 1's CVAP is 49% Latino, while District 3's CVAP is 45% Latino
- Contiguity
 - All six districts are contiguous (Santa Barbara Airport is connected to District 5 via a strip of city territory that runs through the ocean)
- Neighborhoods and communities of interest
 - Neighborhoods that are substantially split: Laguna, West Downtown, Lower State, Westside
 - Potential communities of interest that are substantially split: Central Business District, Historic District, waterfront area, greater San Roque
- **Easily identifiable boundaries**
 - The District 2/3 boundary follows minor streets in the Westside that do not conform to neighborhood boundaries, as does the District 3/6 boundary in West Downtown
- □ Compactness
 - All six districts are reasonably compact


NDC Draft Plan 101R

- The boundary between Districts 1 and 4 is changed so that 1 can have a majority Latino CVAP
- District 3 expands southward toward
 West Beach for purposes of equal population, at the expense of District 2
- Districts 5 and 6 are essentially unchanged
- Gives every district a piece of the coast, except for District 6
- Gives every district a piece of State Street,




NDC Draft Plan 101R, cont.

- Significantly splits the neighborhoods of Laguna, West
 Downtown, Lower
 State, and Westside
- Significantly splits the potential C.O.I.'s of the Central Business District, the Historic District, the waterfront area, and greater San Roque
- Tend to follow boundaries of neighborhoods or major roads
- All districts are reasonably compact




NDC Draft Plan 102R

- District 1 shifts east, away from State St., taking in Laguna
- District 3 shifts west, away from State St., so that it is completely west of the freeway and covers the whole Westside/Lower West
- District 2 shifts east so that it covers the whole waterfront area
- District 6 shifts south so that it covers the whole Central Business District
- Districts 4 and 5 are essentially unchanged




NDC Draft Plan 102R, cont.

- Significantly splits the neighborhoods of Laguna and Lower State, but unites West Downtown and the Westside
- Significantly splits the potential C.O.I.'s of the Historic District and greater San Roque, but unites the C.B.D. and waterfront
- Tend to follow boundaries of neighborhoods or major roads
- District 2 is not compact




NDC Draft Plan 103R

- District 1 shifts east, away from State St., taking in Laguna
- District 3 shifts west, away from State St., so that it is completely west of the freeway
- District 2 shifts west to take in all of southwestern S.B.
- District 5 shifts east to take in all of northwestern S.B.
- District 4 shifts west to take in the area north of Mission St.
- District 6 shifts south to gain the waterfront




NDC Draft Plan 103R, cont.

- Unites Laguna, West Downtown, Lower State, and Westside, but splits Oak Park and Upper East (though follows major streets to do so)
- Unites the C.B.D., H.D., waterfront, and San Roque, plus the hilly areas west of the freeway, though at the expense of splitting the high fire risk area
- Tend to follow boundaries of neighborhoods or major roads
- □ Is District 6 compact?




NDC Test Plan

- District 1 shifts east, away from State St., taking in Laguna
- District 3 expands out from the Westside to take in pieces of Oak Park, Downtown, West Downtown, Lower State, West Beach, and Alta Mesa
- District 6 cuts around District 3 to reach into Bel Air
- District 2 cuts around District 3 to reach into East Beach
- Districts 4 and 5 are mostly unchanged




NDC Test Plan, cont.

- The majority of the CVAP in Districts 1 and 3 are Latino
- The districts are within the threshold of equal population
- The districts are contiguous, but just barely so in cases
- District boundaries do not respect the geographic integrity of neighborhoods, nor are they easily identifiable
- While District 1 is compact, Districts 2, 3, and 6 are not at all




NDC Draft Plan 104

- District 1 shifts east, away from State St., taking in Laguna
- District 3 shifts east into Lower State and part of Downtown for equal population, as well as north to reach into Bel Air
- District 6 crosses the freeway to gain the area between Modoc and the freeway
- District 2 shifts east to take in East Beach and Coast Village
- Districts 4 and 5 are essentially unchanged



NDC Draft Plan 104, cont.

- Significantly splits the neighborhoods of Laguna, West
 Downtown, Lower
 State, and Westside
- Significantly splits the potential C.O.I.'s of the Central Business District, the Historic District, and greater San Roque, but unites the waterfront area
- Tend to follow boundaries of neighborhoods or major roads
- Districts 2 and 3 are not compact





Legality of the Test Plan

- By using a heat map, the only reason for the inclusion of census blocks for a district is the percentage of Latino/a voters. This constitutes **racial gerrymandering**.
- There is also a potential "compactness" issue within the Test Plan.
- Under the current district map, Latino/a constituents have been able to elect their representatives of choice, including Latino/a councilmembers.
