**SUBJECT:** Programmatic Exemption Request for FY 2025

---

The Golf Course is requesting that the IPM Advisory Committee approve the list of materials for programmatic exemption for FY 2025. The Golf Course staff will only use these products (fungicides, insecticides, and herbicides) when accepted thresholds are exceeded. Staff will abide by the manufacturer's label requirements and be in compliance with the California Department of Pesticide Regulation in all aspects of use. These materials are primarily for the greens/collars, tees and fairways and have all been previously approved.

Green:

- **Conserve (Spinosad)**
- **Primo-Maxx/Generic Brands (Trinexapac-ethyl)**
- **Suppress (Caprylic acid)**

Yellow:

- **Acelepryn (Chlorantraniliprole)**
- **Affirm (Polyoxin D salt)**
- **Prostar 70 wp (Flutolonil)**
- **Drive XLR8 (Quinclorac)**
- **Banol (Propamocarb Hydrochloride)                      Pythium rootrot**
- **Ascernity (Benzovindi flupyr/difenconazole) Various pre-emergent**

Red:

- **Scimitar CS (Lambda-cyhalothrin)**
- **Banner-Maxx/Generic Brands (Propiconazole)**
- **Quali-pro Mefen (Mefenoxam)**
- **Velista (Penthiopyrad)**
- **Daconil/Generic Brands (Chlorothalonil)**
- **Clearys 3336F (Thiophanate methyl)**

- Heritage (G and TL) (Azoxystrobin) and various generic
- Insignia (Pyraclostrobin)
- *Combination, pre-mixed fungicides Instrata and Briskway and Goliath and Enclave (all containing approved chemistries)*
- Proxy (Ethephon)
- Torque/Generic brands (Tebuconazole)
- Revolver (Foramsulfuron) (Poa Annua removal in Bermuda/Kikuyu)
- Segway (Cyazofamid) Pythium rootrot
- Lexicon (Fluxapyroxad/Pyraclostrobin) various pre-emergent/contact diseases
