- Daytime Parking Spaces
 - Daytime spaces being looked at include State properties, UCSB, La Cumbre Plaza
 - George Buell agreed to write a letter from the City to State Agencies, outlining the Safe Parking program proven administration record and liability coverage.
 - A meeting between RV dwellers and the City Administrator is scheduled for February 6th, 2017 to discuss the use of Airport property for temporary RV parking.
 - Private spaces not being considered because they are neither part of Safe Parking nor they are included in the Zoning Ordinance. If private property owners are willing to offer spaces, they may do so for daytime use.
 - Kristine Schwarz will release a Public Service Announcement (PSA) from New Beginnings Counseling Center to publicize the program and ask for daytime spaces.

Nighttime Parking Spaces

- Added 14 spaces to Safe Parking (out of which 7 are for RVs).
- Out of a total of 47 RV spaces, roughly half (25-30) are occupied by vehicles.
- Waitlist does not prioritize RV owners.
