Hi, the tree is growing into the power lines, also the tree roots are suspected to be growing into our water service pipe which has developed a large leak & needs to be replaced. We have a strong suspicion that the roots from the tree are responsible for the pipe damage & our plumber thinks that also. Tree removal is necessary in order to perform a water line replacement a replacement tree will be planted in a slightly different location as to avoid any further plumbing problems in the future. At the present time we have shut off the water to the two houses that the pipe feeds meaning the houses are unable to be used. This problem was bought to our attention a few months back when we received a call from the city of SB water department telling us that we were using an unusually large amount of water & upon further investigation water was spilling onto the sidewalk, this is when we decided to shut the water service off at the meter to avoid any further water wastage. I can provide photos at your request, we need to resume the water service to the two houses as soon as possible I am requesting a rapid decision if possible. Thank You WILL YOU REPLACE THE TREE(S)?
