

**CITY OF SANTA BARBARA  
PARKS AND RECREATION DEPARTMENT**

**Summary of Council Actions**

**May 24, 2022 to July 19, 2022**

1. On May 24, 2022, Council authorized the Parks and Recreation Director to execute a personal services agreement with Lobster Jo's Beach Camp, a California Corporation, for the provision of Fiscal Year 2022 and Fiscal Year 2023 Youth Beach Camps, with compensation equal to 90% of the total basic fees collected and the total compensation estimated at \$116,244 based on the projected number of participants.
2. On May 24, 2022, Council authorized the City Administrator to execute a Memorandum of Understanding with CommUnify related to the City's participation in the South Coast Task Force on Youth Safety.
3. On June 7, 2022, Council received the report of the Parks and Recreation Director of the need to make an emergency purchase order (EPO #32201400) to Courseco for a pre-Owned Toro Rough Mower.
4. On June 7, 2022, Council adopted, by reading of title only, a Resolution of the Council of the City of Santa Barbara Prohibiting Stopping, Parking, or Standing of Vehicles on the 1200 Block of Shoreline Drive Adjacent to Shoreline Park from 12:00 am to 4:00 am and Authorizing Removal of Vehicles Unlawfully Parked or Left Standing in Violation of the Prohibition.
5. On June 7, 2022, Council:
  - A. Authorized the Parks and Recreation Director to execute a personal services agreement with 805 Beach Volleyball Club, a Limited Liability Company, for the provision of Fiscal Year 2023 Beach Volleyball Camps, Clinics, Classes, and Tournaments for youth and adults, with compensation equal to 65% of the total basic fees collected and the total compensation estimated at \$175,000 based on the projected number of participants;
  - B. Authorized the Parks and Recreation Director to execute a personal services agreement with Shane Carmody, an individual, for the provision of Fiscal Year 2023 Tennis and Beach Camps and After School Tennis Clinics, with compensation equal to 65% of the total basic fees collected and the total compensation estimated at \$60,000 based on the projected number of participants;
  - C. Authorized the Parks and Recreation Director to execute a personal services agreement with Dave Wilcox, an individual, for the provision of Fiscal Year 2023 Pickleball Classes and Clinic for youth and adults, with compensation equal to 65%

of the total basic fees collected and the total compensation estimated at \$175,000 based on the projected number of participants; and

- D. Authorized the Parks and Recreation Director to execute a personal services agreement with Isaac Rosas, an individual doing business as Youth Evolution Activities, for the provision of Fiscal Year 2023 Basketball and Soccer Classes, Clinics, and Camps for youth, with compensation equal to 65% of the total basic fees collected and the total compensation estimated at \$70,000 based on the projected number of participants.
6. On June 7, 2022, Council:
    - A. Authorized the Parks and Recreation Director to execute annual lease agreements for office space at the Westside Community Center for the Independent Living Resource Center and Momentum Work, Inc. (a recent merge of UCP Work, Inc., and UCP of Los Angeles, Ventura, and Santa Barbara Counties); and
    - B. Authorized the Parks and Recreation Director to execute annual lease agreements for office space at the Franklin Community Center for California Rural Legal Assistance, Inc., and the Santa Barbara County Immigrant Legal Defense Center.
  7. On June 14, 2022, Council authorized the Parks and Recreation Director to execute a Professional Services Agreement with Cardno Inc. in the amount of \$121,058 to update the 2000 Creek Inventory and Assessment Study.
  8. On June 28, 2022, Council authorized the Parks and Recreation Director to execute the renewal of a two-year license agreement with Santa Barbara Masters Swimming for the use of Los Baños del Mar Swimming Pool.
  9. On June 28, 2022, Council authorized the Parks and Recreation Director to execute the renewal of a two-year license agreement with the Santa Barbara Swim Club for the use of Los Baños del Mar Swimming Pool.
  10. On June 28, 2022, Council authorized the Parks and Recreation Director to renew a three-year lease agreement with the Santa Barbara Police Activities League (PAL) for the Twelve35 Teen Center, with an annual rent of one dollar per-year.
  11. On June 28, 2022, Council authorized the Parks and Recreation Director to execute a personal services agreement with iSurf, a California Corporation, for the provision of Fiscal Year 2023 Youth Traveling Surf and Beach Camps, with compensation equal to 90% of the total basic fees collected for the camp and the total compensation estimated at \$185,000 based on the projected number of camp participants.

12. On July 19, 2022, Council authorized the Parks and Recreation Director to enter into agreements with the Santa Barbara Unified School District for the Recreation Afterschool Program and Junior High Afterschool Sports Program.
13. On July 19, 2022, Council authorized the City Administrator to enter into a one-year agreement with the Santa Barbara Unified School District (SBUSD) for Park Ranger Patrol Services at SBUSD properties at a cost to SBUSD in the amount of \$34,546.
