TELEVISION COVERAGE: Each regular Parks and Recreation Commission meeting is broadcast live in English on Channel 18, and rebroadcast in its entirety the Friday immediately following the meeting at 6:00 p.m. and the Sunday immediately following the meeting at 9:00 a.m.

ONLINE STREAMING: Regular Commission meetings are streamed live and can be viewed on the Parks and Recreation Commission website at <u>SantaBarbaraCA.gov/PRC</u> or on the City TV website at <u>SantaBarbaraCA.gov/CityTV</u>.

PUBLIC COMMENT: General Public Comment is held at the beginning of the meeting, and public comments on items listed on the agenda will occur after the discussion of that item. The total amount of time for General Public Comment is 15 minutes. Each speaker will be given a total of 2 minutes to address the Parks and Recreation Commission. Pooling of time is not allowed during general public comment. Members of the public wishing to comment on a matter on the agenda must indicate that they would like to make a public comment prior to the conclusion of the discussion for the item.

IN-PERSON PUBLIC COMMENT: Members of the public wishing to make an in-person public comment must complete a "Request to Speak" form and submit it prior to the time Public Comment is taken up by the Commission.

REMOTE PUBLIC COMMENT: Members of the public wishing to make a remote public comment must "raise their hand" in the Zoom Webinar by selecting the virtual hand icon. The keyboard shortcut for this is Alt+Y for Windows and Option+Y for Macs. Parks and Recreation staff will activate the speaker's microphone when the speaker's name is called. The speaker will then need to unmute themselves. The keyboard shortcut for this is Alt+M for Windows and Command+Shift+A for Mac.
