 - 1. 335 Rosario Drive *Ulmus parvifolia*, Chinese Elm Karen Christman, Arbor Services, Inc.

Commissioner McGill / Aldana to disagree with the Street Tree Advisory Committee recommendation and approve the setback tree removal of the Ulmus parvifolia, Chinese Elm at 335 Rosario Drive on the condition that the applicant replace it with a street tree decided by the City Arborist that can achieve a minimum height of 20 feet or more at maturity. Based on the finding that regard for safety of persons or property dictates removal and that principles of good forest management will be best served by the proposed removal.

2. 138 Santa Rosa Place – *Washingtonia robusta*, Mexican Fan Palm – Mary Jean Headlee

The Commission received the report, they listened to testimony, their questions were answered, and the following action was taken:

Commissioner Aldana / Chang to disagree with the Street Tree Advisory Committee recommendation and approve the setback tree removal of the Washingtonia robusta, Mexican Fan Palm at 138 Santa Rosa Place based on the finding that regard for safety of persons or property dictates removal.

3. 412 Dibblee Avenue - Araucaria heterophylla, Norfolk Island Pine - Ken Davenport

Commissioner Chang / Feck to concur with the Street Tree Advisory Committee recommendation and deny the setback tree removal of Araucaria heterophylla, Norfolk Island Pine.

 - The Commission received the report, their questions were answered, and the following action was taken:

Commissioner Chang / Aldana to concur with the Street Tree Advisory Committee recommendation and approve the various street tree removals at De La Guerra Plaza on the following conditions:

1. The City preserve and transplant tree #46, Trachycarpus fortunei, Windmill Palm, to an offsite location to be determined by the City Arborist.

2. The City modify the landscape plan to reflect the planting of two Markhamia lutea, Nile Tulip Trees, on the side of City Hall, in place of the three proposed Western Redbuds.
