OLD BUSINESS

1. Plan for replacement of SignUpGenius system for regular show space assignments – For Action

Recommendation: Consider implementing the plan reviewed at the June meeting replacing the Sunday space reservation system. Open item to public comment; bring back to Committee for Action.

2. Review rule requiring members to exhibit 5 hours – For Discussion

Recommendation: Continue discussion from the June meeting clarifying the rule requiring members to exhibit a minimum of 5 hours because some members have been disassembling exhibits significantly earlier than 3:00pm. The sentence "Take down of exhibit may not begin until 3:00PM or there will be no attendance credit" was recommended to be added to rule G.1 at a future meeting. Space drawing procedure for Sunday shows

Members can opt-in to have their assigned space automatically reserved each Sunday.

- 1. Members with an automatically reserved space must notify the office by 10:00 am Thursday or leave a message on the Monitor cell by 8:00 am Sunday if they do not plan on attending.
- 2. Members may begin setting up in their own assigned space as early as 6:00 am.
- 3. Members not setting up in their own assigned space will meet at the Palm Park Beach House at 8:30 am Sundays to draw numbers to determine the order they can choose available spaces.
 - a. Members must be present for the drawing; they cannot have another member serve as their proxy.
 - b. Members cannot trade or gift their space.
 - c. Members cannot both have their space reserved and participate in the drawing.
- 4. Members must notify the Monitor as soon as possible if there is an emergency that prevents them from exhibiting on the day they have a reserved space.

Penalties:

- The first violation of either not opting out, trading or gifting space within 2 quarters
 the member will receive a call from staff with a follow-up email reminding them of
 their responsibility to comply with rules and to inform them if a second violation
 occurs within 2 quarters they will not have their space pre-reserved for a period of 1
 Sunday.
- 2. On the second violation within 2 quarters, the member will not have their space prereserved for period of one Sunday. They will be allowed to attend the show and can participate in the drawing for available spaces.
- 3. On the third violation within 2 quarters, the members may have their space prereserved nor participate in the drawing for available spaces; members may exhibit only in a 2nd row or at the end of the Show line.
- 4. The fourth violation within 2 quarters will be treated as an Extreme Code of Conduct Violation and the Parks and Recreation Department will review the case and implement a penalty.
- 5. Penalties for changing spaces do not apply on unreasonable weather days, although space assignments remain valid until 10:00am.

Members can appeal disciplinary action to the Parks and Recreation department.
