Marilyn Loperfido – feels the Show anniversary was overlooked for the upcoming 58<sup>th</sup> Anniversary in May.

Ken Foresta – opposes the system where attendance is the primary criteria at space assignment meetings.

### CONSENT ITEMS

## 1. Minutes – For Action (Attachment)

M/S/C to approve the February 14, 2023 minutes with the addition of "Jim Hockin requested that the City review Coastal Commission regulations before eliminating the requirement for walkways between all space assignments because it provides access to the beach." as public comment under New Business item 1. Staff subsequently noted that the public comment on this item was incorrectly attributed to Jack Bailey and will be replaced with the above text.

Jason Bryan presented participation reports for February and March 2023.

### **OLD BUSINESS**

# 1. Review policy for limited space sharing for reasons other than ADA accommodation – For Discussion

Nicole did not participate in the ad-hoc meeting scheduled by Deborah Healy. Erin and Deborah will move forward as the Advisory Committee representatives on this Ad-Hoc group.

David Drager inquired how to participate in the ad-hoc group. Staff responded that an announcement will be sent to all Show members once a meeting is scheduled by Deborah Healy.

# 2. Schedule will be developed to add 4 Saturday shows to the spring/summer months For Action

Staff presented information on why June 17, July 15, and July 22 were suggested because they align with other events attracting visitors to the area. The Advisory Committee was supportive of these recommendations and were asked to select a 4th Saturday to add to the schedule.

**Public Comment** 

David Draeger – suggested either the weekend before or after Fiesta.

Marilyn Loperfido – August drops off because children are back to school – recommends a date in July. Also requested a 5<sup>th</sup> Saturday be added, but Jason responded that only 4 extra Saturdays were authorized.

Jim Hockin – wanted clarification for extra Saturday shows because they are not consistent with the municipal code that specifies the exact show schedule. Jason Bryan responded that the Parks and Recreation Director has allowed extra show dates in the past and the additional dates were approved by Department Management.

M/S/C to select June 17, July 15, July 22 and August 19, 2023 for the additional Saturday shows

### 3. Minor updates to the Show Procedures and Regulation – For Action

Staff reviewed the proposed Procedures and Regulations updates discussed at previous meetings. Jason Bryan reported that the Department checked-in with the City Attorney's office regarding Jim Hockin's concern about coastal access and Coastal Commission regulations and there were no objections to the proposed rule change.

**Public Comment** 

Jim Hockin – was still concerned that coastal access would be cut off by eliminating spaces between all assignments.

David Draeger – felt the coastal access issue was moot issue because there is a bike path and many natural breaks in the show line

Marilyn Loperifdo – stated there are many gaps between spaces and members have allowed beach access without issue.

M/S/C to approve the proposed updates to Show Procedures and Regulations.

### **NEW BUSINESS**

# 1. Review Fiscal Year 2024 proposed fees for Santa Barbara Arts and Crafts Show – For Information

Staff presented information on a 5% membership fee increase recommendation that aligns with fee increases to most Parks and Recreation programs to be effective July 2023 as part of the City's budget development process.

**Public Comment** 

Marilyn Loperfido - asked if there would be increases limited to every other year and if this increase can be spread over multiple years.

Pamela Newman – understands that it's been a difficult year for some artist, but other shows cost much more than our annual fee for a 2 or 3 day show.

Kevin Healy – shared that some other countries give artists a stipend... but stated show members lucky to have this opportunity in Santa Barbara.

David Draeger – feels fortunate that we're not paying by the foot for space

# 2. Review Cottage Food Vendor policies – For Discussion

Jason Bryan reviewed the Cottage Foods category and a request from Leanne Iverson that Cottage Foods be considered to exhibit in the West section on Saturday Shows. Staff stated that Cottage Foods was created to offer food and beverage in the East section where there were no restaurants or shops nearby. The category followed the State and County's definitions for Cottage Foods for specific shelf-stable foods items. Deborah Healey recalled that her intention when the category was created was for "grab and go" food items that can be consumed at the show and didn't feel items require preparation such as teas fulfilled that intention.

Pamela Newman – suggested that Saturday shows allow Cottage Foods between Garden street and Palm Park Beach House.

David Draeger – stated he wouldn't show on Saturdays if he was a Cottage Foods member. Mr. Draeger opposed allowing space sharing for Cottage Foods members. David didn't want food as a member in the East section.

Jim Hockin – was concerned about competition with restaurants... also felt that Cottage Foods should be restricted to a single person like all other Show members.

Marilyn Loperfido – suggested that pro's and con's be developed before the meeting. Suggested allowing participation on Saturdays, but after other members could secure their spaces. Suggested developing guidelines in the Show rules. Marilyn distributed an information sheet from the State on Cottage Foods.

Kevin Healy – inquired what the intention was when Cottage Foods was first established as a Show category.

Nicole Horstin shared the discissions that took place when Cottage Foods was established as a draw for the East section. Nicole didn't oppose to items that weren't immediately consumable as long as there were some grab and go items available.
