Jason Bryan – Must set a date for Ad-Hoc committee to meet.

Deborah Healy - Will talk to a few show members about availability. Will pick a date to meet before Memorial Day weekend, a weeknight evening.

NEW BUSINESS

1. Review request to have a member commercially print their images on textiles for use in a craft – For Discussion

Jason Bryan – Members have been required to have their own printers for reproductions, but those have been for prints of photography other artwork on canvas or paper..

Deborah Healy – Image that is a focal point on fabric has been acceptable as long as it is the member's artwork.

Erin Duffy – Pattern must be repetitive. Outsourcing is not part of the process. Rules b.2 and b.9 cannot be trumped by b.13.

Brad Kazmerzak – Must be a graphic not a photo. If it is commercially printed fabric, you are not doing the work. Must be your image.

Nicole Horstin – Taking fabric and cutting, sewing makes it into something else. Rule b.9 only pertains to art, rule b.13 pertains to crafts.

Public Comment

Marilyn Dannehower – If you have fabric painted then make it into a poncho or something else that is the result.

Pamela Newman – If photo was on a shirt and you take that photo and make it into something else it should be ok.

David Draeger – Rule b.13 clarifies the other two rules. This should meet the criteria.

Jim Hockin – Must be dominant appeal.

Heather Fletcher – Rule b.13 allows for use of textiles with other people's work on the fabric. Textiles are allowed to be commercially produced.

Marilyn Dannehower – If you buy commercially produced fabric that is ok, but you cannot use your own artwork on fabric?

Jason Bryan – Language in b.13 states that a textile is a type of cloth or woven fabric such as weaving or knitting.

This item needs further discussion to clarify the direction the committee deems acceptable or not acceptable. Need further direction and guidance from show members. Will place on next meeting agenda.
