### 2. Review request to have a member commercially print their images on textiles for use in a craft – For Discussion

a. Suggested addition to the end of rule B.13: “A member may have their own artwork commercially printed on fabric as long as it does not contain a dominant focal point and is used as a raw material that is manipulated to create a functional item.”

Jason Bryan – Language above is a suggestion, Nicole Horstin and I developed as a starting point for discussion..

Brad Kazmerzak – Artist Paints a picture and makes it into a baby blanket. Example – little girl dresses with a football theme. Buying for football theme. Dominant appeal is footballs.

Concerned about opening a door for commercial production.

Erin Duffy– Asked how many members will be affected by this rule change.

Nicole Horstin – All over repetitive pattern is allowed. The problem is someone doing their own artwork and printing on fabric, why? Need to modernize original rule.

Brad Kazmerzak – That person is selling their artwork and commercially printing it. The dominant focal point is the artwork.

Deborah Healy – Issue requires continued discussion. Not ready to bring this to a vote.

Jason Bryan – Strike artwork and say photography? Artwork includes photography. Artwork is not the dominant appeal of the finished work.

Public Comment

Jim Hockin – Get rid of focal point language, replace with dominant appeal.

Deborah Healy – Focal point is a term that was used in screening fabric and textiles, not in art.

Moving forward, back next month.

Jason Bryan – Reads rule B 13. Changes: “artwork may not be the dominant appeal of the finished work“ for the draft rule for review. Discussions will continue next month.
