OLD BUSINESS

1. Review request to have a member commercially print their images on textiles for use in a craft – For Discussion

- a. Consider addition to the end of rule B.13: "A member may have their own artwork commercially printed on fabric as long as the artwork is not the dominant appeal of the finished work and is used as a raw material that is manipulated to create a functional item."

Jason Bryan – We will put this item on the agenda for December 2023 as an action item.

Public Comment

Marilyn Loperfido -Should state all over repetitive pattern. I don't object to this at all. Wording is not objectionable.

Jim Hockin – Adding show member's own artwork to fabric, whether repeated pattern or not, adds a certain personal exclusivity and identity to the work, just like any artists or crafters would in any of their work, but in this case, they would be employing someone else to do that work. Farming out part of the process is against the rules and against everything the show stands for.

NEW BUSINESS

1. **January 2024 Advisory Committee election – For Information**

Recommendation: Advisory Committee terms will expire January 31, 2024, for Erin Duffy and Deborah Healy. Staff will begin a nomination process to fill the positions.

Jason Bryan – Both Erin Duffy and Deboarh Healy’s terms will expire in January 2024. Erin Duffy will not be able to run for the next term as she was an alternate prior to being appointed a Committee Member. Must have a lapse of six months between appointments.

Deborah Healy may run for a second term in January 2024.

Jason Bryan - Will clarify term limits per Municipal Code for Deboarh Healy.

2. **ADA space assignment – For Information**

Recommendation: Pursuant to Procedures and Regulations rule G.10, an assessment was conducted, and ADA space East 98-100 was assigned to Brian Maclaren.

Jason Bryan – Request was approved after a review by City staff Nurse.

Jason Bryan – No, ADA assignments are permanent unless the impairment is short-term.

Jason Bryan – If unable to reach the Monitor, call the Park Rangers.
