3. Public Comment

Marilyn Dannehower – supports equal access using seniority and attendance to determine space assignments. Marilyn hopes to continue to work on those ideals and growing the East section. Marilyn is running for the Advisory Committee position.

Leanne Iverson – would like to support Cottage Foods in the Show. 1. Wants to know if there's a regulation on how far from restaurants food vendors need to be. 2. Doesn't feel cottage foods are attracting members to the East section.

Nicole Horstin – stated this past Sunday was a weather day that left Cottage Foods vendors completely isolated in the East section... want to consider options for weather days.

Kevin Healy –thanked the Committee for their efforts to support the Show.

Marilyn Loperfido –thanked the Committee and asked about the election not being on the agenda.

## OLD BUSINESS

### 1. Review request to have a member commercially print their images on textiles for use in a craft – For Action

Recommendation: Committee will vote on adding the following sentence to the end of rule B.13: “A member may have their own artwork commercially printed on fabric as long as the artwork is not the dominant appeal of the finished work and is used as a raw material that is manipulated to create a functional item.” Open item to public comment; bring back to Committee for Action.

Marilyn Dannehower questioned how the fabric cannot be the dominant appeal?

Jim Hockin repeated what he stated in last meetings that it’s obvious that the artist work appears on the item sold and they’re paying someone else to produce it making it a clear violation.

Leanne Iverson – felt commercially printed material would not be compatible with Show rules when it can be done at home.

Marilyn Loperfido – suggest wording “...the fabric is used as a raw material...” in the rule would be more clear.

Motion did not receive a 2<sup>nd</sup> and will not be on future agendas.

## NEW BUSINESS

### 1. Parking restrictions for Show members – For Information

Recommendation: Staff is reminding Show members that no member parking is allowed in the driveway adjacent to the Palm Park Beach House with the sole exceptions of two vehicles used by ADA members in the spaces in front of the Chase Palm Park Craft Center perpendicular to the creek. Open item to public comment; bring back to Committee for Comment.

Jason Bryan reminded members that parking is not allowed in the driveway adjacent to the Palm Park Beach House including for drop-off and pick-up. Mr. Bryan also reminded members that double-parking and parking in red zones is not allowed with the sole exception of parking in the old trolley drop-off area in front of the bathrooms by the Dolphin Fountain with a permit.

Marilyn Dannehower – asked if a non-ADA person could park in front of the Chase Palm Park craft center. Jason responded that those spaces are the only two parking spaces controlled by Parks & Recreation, and they are designated only for ADA-approved members.

**2. Restroom access at the Palm Park Beach House – For Information**

Recommendation: Staff are reminding Show members that the Palm Park Beach House must be secured when members are using the building's restrooms, and that restroom access is not allowed when the building is rented out. Open item to public comment; bring back to Committee for Comment.

Jason Bryan reminded members that bathroom access at the Palm Park Beach House may be revoked if the facility is left unsecure. Mr. Bryan stated that some members have left the door ajar when using the bathroom for others who may need it, but non-show members often access the building when this occurs, so the doors should be always secured.

The Committee discussed bathroom access overall including the bathrooms behind the Visitor Center. Jason Bryan stated that the Waterfront Department temporarily closed the Visitor Center bathrooms due to ongoing vandalism. The Committee and members present would like to encourage Waterfront to re-open the Visitor Center bathrooms on Show days.

Jim Hockin –encourages the Parks and Recreation Department to encourage Waterfront to reopen the visitors center bathrooms.

Marilyn Dannehower - stated she has seen clean well-maintained bathrooms in many other Southern California cities.

Nicole Horstin – suggested Waterfront can use some of the funds from the cruise ships to maintain the Visitor Center bathroom.
