  location and coloring to match the building, which does not apply generally to other
  properties in the vicinity.
- 2. The granting of the exception will not be materially detrimental to the public welfare or injurious to the properties or improvements in the vicinity.
- 3. The proposed sign is in conformance with the stated purpose and intent of the Sign Ordinance.

- 3. The proposed sign is in conformance with the stated purpose and intent of the Sign Ordinance.
- 4. The Board appreciates the applicant's compliance to raise the height of the signage to be consistent with other signs in the area.
- 5. Letter height shall be reduced to 10-inches due to the proximity of the sign to State Street
